2YR: Sideways trend. 18-month rally. Break of 6000 now possibly turned support. Resistance at 6140 3MO: Uptrend. Breakdown from rising wedge after test of 2011 highs. Support 6050. Resistance at 6115 1MO: Uptrend. Breakdown from rising wedge. New channel developed. Support 6070. Resistance at 6130 1WK: Uptrend. Breakdown from rising channel. New falling channel in formation. Support 6070. Resistance at 6130

#### Major Support & Resistance (pivot points - explained): Pivot: 6115; Support: 6099, 6070, 6054; Resistance: 6144, 6160, 6189

Now we've pulled back from 2011 high (6140), hovered around 6100 and registered lower high (6130) overnight, a new channel/broadening pattern started to form. This opens up possibility of correction back to 6050 level flagged since early Jan. Focus seems to be reverting to negatives which never really went away. US still has work to do - Bernanke says so, politicians not helping. Poor German GDP reading didn't help for the eurozone. Japan's yen-weakening-stimulus talk run its course? Results only just begun, but not screaming growth. Caution has returned....after exactly 2 months rallying.
